- I. Chris Piecuch: (In regards to All-State)
  - A. Students did not know seating results until a week before the conference; therefore, wind players did not know what parts to prepare
  - B. **Jason Deem:** Will reach out to resolve this issue in the future.

**II. Michael Neal:** String players in middle and east TN received their All-State music before our region.

- A. **Chelsea Subick:** This may be because middle and east have their conferences first, so they receive the music sooner.
- B. **Jason Deem:** Music should be released at the same time. Will reach out to fix this issue.

#### **New Business**

- **I. Robyn Greene:** Motion made (& 2nd) to add a second Middle School Orchestra to the All-West Clinic. This change should align with the Middle School Bands.
  - A. Rationale: The majority of the string caucus would like to see the opportunity of participation in an "honors" style ensemble expanded to more interested students. Only 29% of auditioning violin students, 39% of viola students, 31% of cello students, and 53% of bass students earn placement. While the numbers for viola, cello, and bass are better, it is our feeling that a greater number of students will attempt the audition if the odds of success are more in their favor.
  - B. Discussion: (Benjamin Martin): This addition would cost roughly \$5,000.
    Brad Turner says this is doable. We cannot implement this next year due to the bookings we've already secured at the Sheraton and Cannon Center. We could start in 2026.
  - C. Discussion: (Chris Piecuch): Orchestra should have the same opportunities as band
  - D. Discussion: (Robyn Green): The orchestra teachers have discussed applying for grants or receiving funding from outside WTSBOA.
    - a. (Benjamin Martin): We have nothing like that in place now, but we can look into it.
  - E. Discussion: (Benjamin Martin): The sizes of the ensembles would have to be the same. This is in the constitution.
  - F. Discussion: (Sam Schirmer): More students would be making All-West, so these registration fees may cover new expenses.
