# **President's Report**

- V. The board has tried to make All-West Auditions easier by moving to Competition Suite (instead of scantrons). There are too many issues with integrating data and keeping students anonymous. This year, we will continue to use our scantron. We are still looking for solutions.
- VI. Introduction of JR Baker and Michael Chester Michael Chester:
  - a. TMEA Board of Directors and Council met concerning a bylaw provision teachers would have the right to choose to join NAfME
    - i. Results were 19 to 1 in favor of changing the bylaws. Membership in NAfME is now optional.
    - ii. TMEA is working with NAfME on next steps for those teachers that wish to join.
  - b. Regions are going to have more of a say in TMEA

- c. TMEA is committed to looking at the challenges that are facing directors and moving forward
- d. 2025 TMEA Conference performing groups and PD sessions will be announced soon.
- e. TMEA has a new contract with Opryland that extends from 2027-33. More info will be sent out about this.
- f. The 2027 Conference will be moved to January (instead of April)
  - i. TMEA Conference is expanding to create middle school ensembles, Elementary Orff Ensemble, and will continue having an Elementary Treble Choir.
- g. TMEA will possibly be offering or helping teachers secure grants to travel and attend future conferences.
- h. TMEA will be working on finding other hotels in the area (besides Opryland) that will offer the TMEA Conference Rate. This will give educators a choice on where they stay.
- VII. Benjamin Martin: All-West Audition music revisions = Middle School wind instruments may play 2 excerpts instead of 3.
