#### **Old Business**

- I. Jason Deem: All-West Music Committee
  - a. We formed a committee at the February meeting to re-evaluate music for All-West Auditions for Middle School, 9-10, and 11-12 bands.
  - b. 3 people were chosen to lead the committee, and each will present findings and suggestions
  - c. Auditions are moving to November
- II. Patrick McDermott: Middle School Band Music

  - b. Proposal: Remove one excerpt (go from 3 to 2) keep one technical and one lyrical

- IV. Patrick McDermott: 11-12 Band Music
  - a. Keep music as it is release the audition cuts earlier than 2 weeks before auditions
- V. Micaiah Radcliffe: Percussion
  - a. Present Issues: Audition rooms get behind and music is too difficult

- VI. Jason Deem:
  - a. TMEA is going to require all regions to use the same music in future years
  - b. Our committee leaders will be the voice of west TN at the state level
  - c. Any funding needed for changing music will be paid for by TBA and TMEA
- VII. Jason Deem: Scales
  - a. Proposal: No scale rotations. Required scales are released 48 hours before audition day.
  - b. Rationale:
    - i. All students prepare the same music, but their scales are different

- ii. We are the only region where students do not play the same scales, we are the only region with a scale rotation, we are the only region that doesn't release scale requirements before audition
- iii. Our job as an association is to put adjudicators in the best position to adequately score students
- iv. Judges may not even know if a student is playing the correct scale
- c. Further discussion
  - i. Chromatic Scale will still be used to show range
  - ii. Middle School scales will still meet the parameters set in the bylaws
  - iii. Scales will be selected per instrument (not all winds will be playing the same scale)

Motion made for all percussion scales, including chromatic scale, to only be played two octaves.

#### **Motion: Jason Deem**

Motion made for wind players in grades 5-12 auditioning for Band to play 2 scales plus a chromatic scale. These will be the same scales for all students on that instrument. Scales will be released 48 hours before auditions.

Motion made for all wind and percussion players in grades 5-12 auditioning for Band to play 2 scales plus chromatic scale. These will be the same scales for all students on that instrument. Scales will be released 48 hours before auditions.

Motion made to change the violin seating (Article VIII) to read: Violins 1-6 will play 1<sup>st</sup> part; Violins 7-12 will play the first 3 stands of the 2<sup>nd</sup> part and will retain their All-State status. Violins 13-26 will play to the last 7 stands of the 1<sup>st</sup> part. Violins 27-40 will play the last 7 stands of the 2<sup>nd</sup> Violin part.

Motion made to change the violin seating to read: Violins 1-6 will play 1<sup>st</sup> part, Violins 7-12 will play the first 3 stands of the 2<sup>nd</sup> part and will retain their All-State status. Violins 13-28 will play to the last 8 stands of the 1<sup>st</sup> Violin part. Violins 29-44 will play to the last 8 stands of the 2<sup>nd</sup> Violin part.

#### **ATTACHMENT 1: All-West Music Committee Review**

#### **SCOPE**

The all west music review committees went through and rated all of the all west using the **TBA** rubric for reviewing concert literature.

We reviewed the excerpts from **middle** and **east** Tennessee's region band auditions to see how our music stacked up in total measures and note count.

#### **MSFINDINGS**

On average:

WTSBOA has approximately **211.64** notes per excerpt.


Other regions have approximately **101.20** notes per excerpt.

That means WTSBOA has about **110.43** more notes on average than the other regions across all instruments.

Here are the instruments ranked by how much WTSBOA's note count differs from the average of other regions (largest variance first):


- 1. Trumpet **152.75** more notes
- 2. Bass Clarinet **118.67** more notes
- 3. Clarinet **115.00** more notes
- 4. Saxophone **115.00** more notes
- 5. Horn **111.00** more notes
- 6. Tuba **108.00** more notes
- 7. Oboe **107.80** more notes
- 8. Flute **104.80** more notes
- 9. Euphonium/Baritone **97.75** more notes
- 10. Bassoon **97.00** more notes
- 11. Trombone **87.00** more notes

Trumpet shows the most significant variance, meaning WTSBOA gives its players a much heavier workload compared to other regions.



#### **CHANGES**

There is a high probability that in the 2027-28 school year, the state will move to make one set of excerpts for the state band auditions.



#### HS INTRO & ADJUSTED SCOPE

Initially looked to replace 9-10 with excerpts
Initially looked to fine-tune 11-12 etudes
Potential state changes led to changing scope to be more short-term oriented

#### **HSFINDINGS**

We counted a lot of notes! (thanks HS TAs)

Our HS rep has many more notes than other regions, just like MS did.

Committee members disagreed on impact of the number of notes in our music

#### **OUR SUBCOMMITTEE RECCOMENDATIONS (NOW)**

While some members disagreed, a majority believe we should (assuming auditions are moved up):

**Remove the third excerpt** from each 9-10 rotation.

**Give students more time** with the audition cuts for 11-12 rotation

#### **OUR SUBCOMMITTEE RECCOMENDATIONS (NEXT)**


We should also:

Continue this subcommittee to represent our organization at the state level.

Allow anyone interested in this new scope of our subcommittee to join.

Intentionally represent the majority opinion of our membership at the state level, advocating to not greatly reduce difficulty from current WTSBOA audition repertoire

#### ALL WEST PERCUSSION MUSIC REVIEW

### There are a number of consistent issues members have with our percussion audition process and content:

Audition rooms get behind Sections of audition music are not idiomatic to the instrument Sections are unnecessarily difficult Excerpts are not musical

### ISSUE#2

- Sections of audition music are not idiomatic to the instrument:
  - If not deleted in the previous step, remaining un-idomatic segments were rewritten.

## ISSUE#3

- Sections are unnecessarily difficult:
  - Sections that were not grade level appropriate or unnecessarily difficult were deleted or rewritten.

### **ISSUE#1**

#### Audition rooms get behind:

- MS and 9-10 prepared pieces are twice as many measures total as their WTSBOA wind counterparts.
  - Each excerpt was about 20 measures (60 total) vs approximately 32-36 total for the winds
  - WTBOSA percussion etudes have on average twice as many measures as our other regional counterparts.
- We edited down each exerpt to be roughly 12 measures, so all total it is about 36 measures, mainly eliminating repetitive material.
- We would like to propose limiting percussion scales to 2 octaves:
  - Nothing changes after the second octave from a technical standpoint. Playing 4.3 octave chromatic scale on a keyboard just means you know how to step to your right and left.

### **ISSUE#4**

#### • Exerpts are not musical:

- Feedback from Dr. Shaltis (UofM) and Dr. Shoupe (UTM) pointed out how unmusical many of the exerpts were
- more expression marks and dynamics were added to allow for more guidance, and some changes were made to provide more musical and expressive variety

## **SPECIAL NOTE: 11-12**

- The excerpts affected most dramatically were the 11-12 grade marimba.
  - 11-12 are the excerpts that are complained about most often.
  - These required significantly more technical skills that other state regions.
  - o In the edit for this next rotation we:
    - limited the 4 mallets skills to double verticals and inside mallet single independents strokes, which would align with a college audition skillset
    - Decreased the tempo (which was an unneccesary difficulty)
    - transposed to a new key to avoid un-idomatic voicings of chords

# RECCOMENDATION

#### • Possible complete rewrite

- These edits are a band-aid fix to work with our shorter preparation period for November Auditions.
- With the upcoming state wide audition music, this will be the perfect opportunity to start over.
- If the state excerpts do not take effect after this year, we can get feedback from the membership and do another round of edits for the next rotation.
- The committee will establish parameters for an optimal percussion audition for each grade level and present to the state-wide music committee.
